A. Deduct \$0.02 per degree API for each whole degree below 40.9 degrees API.

Deduct \$0.15 per degree API for each whole degree above 54.0 degrees API.

B. Deduct \$0.02 per whole degree API for each whole degree API from 40.9 degree API to 35.0 degree API.

Deduct \$0.15 per 1/10 degree API for each 1/10 degree below 35.0 degree API.

Deduct \$0.15 per degree API for each whole degree above 44.0 degree API.

C. Deduct \$0.02 per degree API for each whole degree below 29.9 degree API

D. Flat

E. Deduct \$0.02 per degree API for each whole degree below 40.9 degree API

F. Deduct \$0.15 per degree API for each 1/10 degree above 60.0 deg. API.

G. Deduct \$0.015 per degree API for each 1/10 degree above 60.0 deg API.

Deduct \$0.02 per degree API for each whole degree below 40.9 degree API to 35.0 degree API.

Deduct \$0.015 per degree API for each 1/10 degree below 35.0 degree API.

H. Deduct \$0.015 per degree API for each 1/10 degree above 60.0 deg. API.

Deduct \$0.015 per degree API for each 1/10 degree below 34.0 deg. API.
